Workshop on Transdisciplinary research methodology in Milan

Social Polis is planning to hold a Network's workshop on Transdisciplinary research methodology in urban cohesion action 28 September 2011.

Since Serena Vicari and Flavia Martinelli are organising a special session on Social innovation and cohesion in the contemporary European city at the ESPANET conference (<http://www.espanet-italia.net/conferenza2011/>) that will take place in Milan from September 29 to October 1, we are thinking of combining the events, in order to optimise travel and accommodation costs and network visibility.

Therefore, we will hold the Social Polis workshop on Wednesday the 28th of September (full day), with the possibility for those wishing to present a paper at the ESPANET conference to do so in the next days (Thursday afternoon or Friday morning at the latest, depending on the scheduling of the special session, yet to be determined).

This said, we would like to know as soon as possible from each of you:

1. Whether you wish to attend the Social Polis Workshop on "Transdisciplinary research methodology in urban cohesion action", to be held in Milan on September 28, 2011, from 9,00 to 18,00, at the University of Milano Bicocca. **In case you decide to attend please send a 15 line abstract to Frank Moolaert and Davide Cassinari by May 1.**
2. Whether you will be able to finance your travel and accommodation expenses or you will need funding from the Social Polis extension budget, in which case please provide us with an estimate of travel and accommodation costs. There is a budget of 6000€ available, with a positive discrimination for those among you who do not have their own research funding. **We will only fund those presenting a paper at the Transdisciplinary research methodology in urban cohesion action Workshop.**
3. Whether you would be interested in presenting a paper on a case study studied in the course of the project at the

ESPANET conference, to be held at the Politecnico of Milan, from September 29th to October 1st 2011, within the special session on Social innovation and cohesion in the contemporary European city (<http://www.espanet-italia.net/conferenza2011/cfa-9.php>), in which case please give us a provisional title. Please note that abstracts of the papers to be presented at the conference will have to be sent to Serena (serena.vicari@unimib.it) by April 15, 2011. Serena and Flavia are also planning to collate some of the papers presented at the session into an edited book or a special issue of an Italian journal.

Summary of the call for sessions

Social justice and democratization have been topics tackled at length by urban studies in general and urban sociology in particular. Cities have always been social laboratories in which the mechanisms that create and reproduce social inequalities are addressed and innovative solutions are found. Political transition processes experienced by different countries over the past decades have shown how social justice is just at the centre of democratization demands, and how social movements rooted in cities, or focused on urban demands, have been at the forefront of those demands.

The analysis of the relations between democratization, social justice and spatial processes of change is the focus of the sessions proposed by RC21.

Sessions should consider the current context of global change in both the world economy and the emerging geopolitical configurations and their consequences at the urban and regional level. Sessions may focus on specific dimensions of social justice and democracy (or the lack of) at different territorial levels. They may address innovative ways of contrasting inequalities and poverty or they may analyze the promotion of the quality of life and of social, economic and ecological sustainability.

Priority will be given to proposals fostering comparisons and methodological innovation, centred on the comprehension of the mechanisms that generate social (in)justice and/or (in)equalities at the regional and local level and their scalar relations, and on the responses- both social mobilizations and policy interventions- to these.
